


WHAT DO I NEED TO APPLY FOR MY CUBAN TOURIST VISA?

A photocopy of the bio page of your passport. The passport must be valid for at least 6 months.

One completed and signed application form.

A copy of your flight itinerary (return tickets).

A copy of your travel insurance, which should be valid for the entire trip.

Booked accommodation

Please note: once processed your Cuban tourist card will be posted using Royal Mail. Please make sure to verify the address in the questionnaire below.

How long the visa take to be organized?

The standard processing time is 5 working days once we have received all relevant documents from you.

How much time can I spend in Cuba?

The visa is activated once you enter Cuba and will allow you one entry / one exit, and a maximum of 30 days to stay in Cuba from your arrival date. A Cuban Tourist Card can be extended locally for another 30 days while in Cuba, this being the maximum any tourist is allowed to remain in the country (60 days).

Please note that, other documents may be requested at the discretion of the embassy. The provided processing time is given as a general guidelines - actual waiting times may vary. The visa fee is non-refundable even in the event that your application is delayed or rejected.

Passports are required for the entire processing time. In the event of loss or damage to any passport or documents received, Visa First liability will be limited to the actual value of the passport/document. Visa First accepts no liability for consequential loss.

You must travel with the same passport you hold at time of completing this application. If you obtain a new passport after your visa has been issued, please contact the Visa First help desk for advice. In this case reallocation fees may apply.

Visa First advises against purchasing restricted or inflexible tickets prior to visa issuance. Processing times shown on this application are standard processing times. While Visa First makes every effort to ensure that visas are processed according to advertised timelines, Visa First does not accept any claims for delays caused by postal strikes or delayed post handling by postal companies or embassies which are outside of our control.

It is the client's own responsibility to ensure that they familiarize themselves with their visa validity dates and ensures all details on the visa are correct. The client must enter the country to activate the visa before the visa expiration date.
